## **POLICY**

Community Living Thunder Bay (CLTB) shall strive to exceed the minimum standards of quality assurance as per Ontario Regulation 299/10, made under the SERVICES AND SUPPORTS TO PROMOTE THE SOCIAL INCLUSION OF PERSONS WITH DEVELOPMENTAL DISABILITIES ACT, 2008 as well as standards set out by the DAY NURSERIES ACT. In order to measure compliance rates, CLTB shall implement a systemic monitoring and evaluation process of the various aspects of our service delivery system.

#### PROCEDURE:

Evidence shall be gathered on an annual basis to establish quality in supports and services.

- A minimum of ten percent of files of all people supported will be audited twice a year by the Quality Assurance Team in order to ensure compliance with the SERVICES AND SUPPORTS TO PROMOTE THE SOCIAL INCLUSION OF PERSONS WITH DEVELOPMENTAL DISABILITIES ACT, 2008, and the DAY NURSERIES ACT.
- A minimum of thirty percent of the Individual Support Plans will be reviewed by the Quality Assurance Team in order to ensure consistency and quality related to the person's goals, preferences and needs.
- An annual review of the Internal Rights Review Committee shall be conducted by the Quality Assurance Team in order to evaluate the effectiveness of the process.
- CLTB will endeavour to review and revise all policies and procedures on an annual basis. The Quality Assurance Team will develop and maintain a calendar in order for each department to be aware of when their policies and procedures are up for review.
- The Policy Review Committee will review, evaluate and approve new policies.
- The Quality Assurance Team will evaluate the agency's staff training plan annually in order to ensure applicability and effectiveness.
